
Q1 The problem of domestic violence and child abuse is not just a problem for the NFL, it is a societal problem and the solution lies with all of us.



Q2 Do you think we need more opportunities for effective community responses to domestic violence and child abuse such as: (Check all that apply)





Q4 How would you react if your employer (or an organization you're connected with) took such action against domestic abuse and/or child abuse?



Q5 At your work place (or at workplaces in general), do you think it would be helpful to have: (Check all that apply)



Q6 I want to be part of the solution to domestic violence and child abuse, but I am just not sure how to help or what to do.


